No other agreement, statement, or promise not contained or referenced in this "Artistic Works Release Consent and Agreement" shall be valid or binding. ORGANIZATION is not obliged to make any use of my ARTISTIC WORKS or exercise any of the rights granted to them by this release.

All rights granted herein, by me to ORGANIZATION, as well as all terms of this agreement and consent, shall insure to the benefit of the successors and assigns of ORGANIZATION.
