Title: Signing Away Your Truth: Reading the Fine Print (S6, E19)

Description: Gretchen Carlson is a fierce, fearless, and internationally recognized advocate for women's rights, whose bold actions against Fox News Chairman Roger Ailes helped pave the way for the global #MeToo movement. A former CBS News and Fox News journalist, author, TED talk alum, and champion for workplace equality, Carlson was named one of Time Magazine's "100 Most Influential People in the World." She co-founded the nonprofit Lift Our Voices which works to eliminate silencing mechanisms in the workplace and was recently instrumental in passing two of the biggest labor laws in the last century. This week, she shares her voice and expertise to inspire, connect, and empower our community of survivors and supporters.

Title: Splitting the Law (S6, E15)

Description: "How much is a little girl worth?"

Guided by a strong sense of justice since she was young, Rachael decided at ten that she wanted to be an attorney. However, her experience reporting abuse in her church comes with a terrible lesson: don't report unless you can prove it. Taking this to heart, when her gymnastics coach Larry Nassar sexually assaults her, she stays silent.

16 years later, supported by investigative journalists and public outrage, she reports her abuse, becoming the first whistleblower and rallying an army of survivors to bring Larry Nassar to justice. Today, Rachael Denhollander speaks across the country to make change in institutions ranging from the government to religious organizations, pursuing survivor healing and institutional transformation.

Description: This week, Helene Weiss and Grant Boyd share their experiences advocating for survivors and working tirelessly to protect their rights in the courtroom. They share visions of hope and victory, bringing to light brave survivors who have pushed to make their voices heard and fight for themselves and their community.

Helene Weiss is a partner at Marsh Law Firm and works on a wide range of cases representing survivors of sexual abuse. She is a former Special Victims Bureau Prosecutor who has tried dozens of cases from jury selection to verdict, both criminal and civil. Helene also works as an Adjunct Professor of Law at Hofstra University, teaching Advanced Trial Skills.

Grant Boyd is an attorney from St. Louis, Missouri. His practice focuses on representing sexual abuse survivors and families of victims. In just 10 years as an attorney, Grant has won over half a billion dollars for crime victims and continues to assist victims in navigating criminal cases.

Description: This week we share the powerful voices of Jon Vaughn and Josh Rubin. Jon Vaughn made waves around the world as one of the few to publicly speak out against the abuse



of University of Michigan doctor Robert Anderson in 2020, leading over 1000 survivors in a lawsuit against the university that settled in 2022. Today, he is a testament to the power of speaking out and advocating for what is right against all odds.

Description: "No one ever regrets fighting the good fight, whether it is for yourself or for your children."

In this episode, Amanda Lee (Bubbles & Bubbly in a Bottle) discusses her experience with justice. To bring an expert perspective into the conversation, we invite Michael Leshner, a lawyer and writer, to discuss the American justice system. Michael has authored publications focused on the experiences of protective parents going through divorces where the other parent is the child's abuser. The family court might be looking out for the child's best interests, but in cases like this, conventional practices can be dangerous - whistleblowers can face incredible scrutiny from the justice system, an added trauma to the struggle to protect their children. Today, we bring to light an often overlooked aspect in the fight to prevent sexual violence and seek justice for survivors.
